COUNTY HIGHWAY SUPERINTENDENT

DISTINGUISHING FEATURES OF THE CLASS: This position involves responsibility for overseeing, coordinating, and managing construction of new highways and repair and maintenance of existing highways, bridges, and related public work activities performed either by county employees or private contractors. Additionally the incumbent works with officials of the state, towns, and villages relative to cooperative or contract maintenance, repair, or snow removal activities. The incumbent exercises direction and control over the Departments of Highway. The work is performed under the general direction of the County Administrator with wide leeway allowed for exercise of independent judgment in assigning of personnel and work methods. Supervision is exercised over the work of all subordinate department employees. The incumbent does related work as required.

TYPICAL WORK ACTIVITIES: (Illustrative only)

Plans, assigns, and supervises county highway and bridge construction, maintenance, and repair through the efficient use of work crews, equipment, and materials;
Consults with Deputy Superintendents and engineering staff on new designs for highway planning, road widening, and complete highway reconstruction;
Oversees and prescribes highway and related public works construction and maintenance policies to subordinate department personnel;
Prepares departmental budgets and confers with County Administrator in formulating public works' improvement programs;
Furnishes technical advice to County Administrator, County Legislators, Town Highway Superintendents, and other officials concerning public works matters;
Represents the county at meetings and seminars provided by Federal and State agencies pertaining to county public works functions;
Plans Department activities with deputies and sets standards of performance;

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES & PERSONAL CHARACTERISTICS:

Comprehensive knowledge of modern principles and practices of public works administration;
Comprehensive knowledge of engineering principles and practices as applied to the administration of diversified public work activities;
Thorough knowledge of the construction trade;
Thorough knowledge of laws and regulations relating to Public Works departmental activities;
Thorough knowledge of legislative practices and procedures;
Thorough knowledge of sources of engineering information and ability in applications of engineering procedures, techniques, and methods;
Good knowledge of budget process;
Demonstrated ability to direct and supervise public works activities on a large scale and in a coordinated manner;
Demonstrated administrative ability;

Ability to establish and maintain effective working relationships with subordinates, other governmental officials, and agencies and the public;

Knowledge to secure grants and other financial aide;

Initiative and resourcefulness in handling general administrative and engineering problems.

MINIMUM QUALIFICATIONS: Either

- (a) Possession of a Master's Degree in Engineering from a regionally accredited or New York State college or university and four (4) years of engineering management experience; or
- (b) Graduation from a regionally accredited or New York State registered four year college or university with a Bachelor's Degree in Engineering and five (5) years of engineering management experience; or
- (c) An equivalent combination of training and experience as defined by the limits of (a) and (b) above.

NOTE: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. SPECIAL REQUIREMENT: Eligibility for a New York State Professional Engineer's License at time of application. Possession of license at time of appointment.
