The County of Clinton hereby elects to provide all employees of the Clinton Community College who are members of the New York State Teachers' Retirement System and the Teachers Insurance and Annuity Association College Retirement Equities Fund, with a retirement incentive program authorized by Chapter 665, Laws of 1984.
- $\underline{\text{Section 2}}.$ The commencement date of the retirement incentive program shall be June 3, 1985.
- Section 3. The open period, during which eligible employees may retire and receive the additional retirement benefit, shall be ninety (90) days in length.
- Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a five year period.
