Section I. Legislative Intent:

The Clinton County Legislature heretofore having recognized the growing complexity of the operation, management and administration of the Clinton County Nursing Home; and having determined that the most efficient and economic manner for providing health care and operation of the Health Facility can best be administered as a separate department of County Government.

Section II. Pursuant to provisions of Section 10 of the Municipal Home Rule Law, there shall be a Clinton County Nursing Home and related Health Facility Department, the head of which shall be the Nursing Home Administrator, who shall be responsible for the management and operation of the Clinton County Nursing Home and related Health Facility. Such Administrator shall be appointed by the Clinton County Board of Legislators and shall have the powers and duties necessary to carry out those functions of the department set forth herein and such other responsibilities as may from time to time be imposed by resolution of the Clinton County Legislature or other legislative or regularity mandates relating to the management and operation of the Clinton County Nursing Home and related Health Facility, as may be imposed by the State of New York or the United States of America. The Administrator shall render an annual report of the department's activities to the County Administrator and shall oversee the preparation of an annual budget for the department. Within the appropriations made therefore, the Administrator shall appoint, supervise, discipline and remove employees of the department and assign and reassign powers and duties to such employees.

Section III. This Local Law shall become effective upon the filing in the Office of the Secretary of State as prescribed by Section XXVII of the Municipal Home Rule Law.

Section IV. Savings Clause: If any clause, sentence, paragraph, section or part of this Local Law shall be adjudged by any Court of competent jurisdiction to be invalid such judgment, decree or order shall not effect, impair or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part thereof, directly involved in the controversy in which the judgment, decree or order shall have been rendered and the remainder of this local law shall not be (if additional space is needed, please attach sheets of the same size as this and number each)
