A local law Providing a Procedure for the Transfer of Interests

in Property Acquired by Clinton County for Airport Purposes

Be it enacted by the County Legislature of the

Section 1. Intent and Purpose. It is declared to be the intent and purpose of this local law to enable the County of Clinton (the "County") to establish a procedure for the transfer of interests acquired by the County for airport purposes which varies from the procedure established by section 352 of the General Municipal Law.

Section 2. Public Purposes. The County may lease to County of Clinton Industrial Development Agency, for a term not to exceed forty years, real property leased or otherwise acquired by the County at the former Plattsburgh Air Force Base.

Section 3. Procedure for Authorization. Each lease of real property to be made by the County to County of Clinton Industrial Development Agency pursuant to this local law shall be conditioned upon approval by the county legislature of the terms and conditions of such lease. Such approval shall be evidenced by a resolution adopted by the county legislature indicating its approval of such terms and conditions.

Section 4. Severability. If any section, clause or provision of this local law or the application thereof to any person or circumstance shall be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the section, clause or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this local law or the application thereof to other persons or circumstances, and the county legislature hereby declares that it would have passed this local law or the remainder thereof had such invalid application or invalid section, clause or provision been apparent.

Section 5. Inconsistent Enactments. All ordinances, local laws and parts thereof inconsistent with this local law are hereby repealed.

Section 6. Effective Date. This local law shall become effective upon the filing thereof in the Office of the Secretary of State of the State of New York, as provided for in the Municipal Home Rule Law.
