Staff Reports

County Attorney – Jacqueline Kelleher, Esq.

Jacqueline Kelleher, the County Attorney, requested an Executive Session to discuss Collective Bargaining.

County Administrator - Michael Zurlo

Mr. Zurlo stated he would also like to discuss the sale or potential lease of real property in Executive Session.

Mr. Zurlo reported he is hoping to hear what is included in the budget bills sometime tomorrow.

There being no further business, Chairperson McManus moved on to resolutions. The following resolutions were approved unless otherwise noted:

Resolutions #239 through #242 were approved. Carried (9-0-0-1).

Resolution #243 titled, "Authorizing Non-Aviation Lease Agreement with Novacab – Plattsburgh International Airport"

Discussion: Legislator Hall welcomed Novacab on behalf of the Plattsburgh International Airport Committee and wished them nothing but success. Novacab will start out with between 20 to 30 employees. Carried (9-0-0-1).

Resolutions #244 through #246 were approved. Carried (9-0-0-1).

Resolution #247 titled, "Authorizing Contract with Provost Drone Solutions – Plattsburgh International Airport" was moved by Legislator Hall and seconded by Legislator Conroy.

Discussion: Legislator Rosenquest motioned to table the resolution for further clarification/information, seconded by Legislator Hall. Carried (9-0-0-1).

Resolutions #248 through #252 were approved. Carried (9-0-0-1).

Legislator Conroy motioned to Waive Rule 13.2, seconded by Legislator Rosenquest. Carried (9-0-0-1).

Resolutions #253 titled, "Authorizing Contract with Clinton County Capital Resource Corporation for Administration of Foreign Trade Zone #54 – Legislature" was approved. Carried (9-0-0-1).

Discussion: Mr. Zurlo stated Clinton County has Foreign Trade Zone (FTZ) #54 and for years, it was administered by The Development Corporation (TDC). TDC is seeking removal from the administrative duties. The Clinton County Capital Resource Corporation has agreed to administer FTZ #54.

Resolution #254 titled, "Amending Resolution #230 dated March 13, 2019 titled, "Authorizing the Purchase of Two Ford F-550 Crew Cab Chassis Trucks and Two Iroquois Stake/Platform Body Units – Highway Department" was approved. Carried (9-0-0-1).

Discussion: Mr. Zurlo reported the Transportation Committee was polled on this Resolution earlier in the day. The County inadvertently awarded the bid to what was thought to be the lowest bidder. There was some language discrepancy in the bid document, and the Purchasing Agent caught the error and talked to the Highway Superintendent and the Office of General Services. This Resolution will award the bid to the low bidder.

Legislator Henry motioned to enter into Executive Session at 7:17 p.m. to discuss Collective Bargaining and the potential sale or lease of real property, seconded by Legislator Rosenquest. Carried (9-0-0-1).

Legislator Rosenquest motioned to exit Executive Session at 7:28 p.m., seconded by Legislator Keenan. Carried (9-0-0-1).

There being no further business to come before the Legislature, Legislator Hall motioned to adjourn the meeting at 7:29 p.m., seconded by Legislator Rosenquest. Carried (9-0-0-1).
