James Coffey, Esq., County Attorney Melody Lemieux, Principal Stenographer Chairperson McManus called the meeting to order at 7:00 p.m.

Following the pledge of allegiance to the flag, County Administrator Michael Zurlo conducted roll call. Legislator Rosenquest was excused.

Legislator Hall motioned to accept the minutes of the December 12, 2018 Regular Session, seconded by Legislator Keenan. Carried (9-0-1).

Chairperson McManus asked if anyone wished to address the Legislature.

Samuel Dyer, Town Supervisor of the Town of Beekmantown and former County Legislator from Area 3, publicly congratulated James Coffey, Clinton County Attorney, on his retirement as County Attorney. Supervisor Dyer stated he has thoroughly enjoyed working with Mr. Coffey during his term on the Legislature. The County has been well served with Mr. Coffey's guidance, and he wished him well and will remain in contact with him.

Chairperson McManus and Legislator Henry presented Supervisor Dyer with a plaque of appreciation commending him for his years of service as County Legislator from Area 3.

Clinton Community College - Legislator Dame

Legislator Dame reported in an effort to reduce costs at Clinton Community College, there was no Winter Commencement exercise this year.

Legislator Conroy reported the December meeting was cancelled.

Lake Champlain/Lake George Regional Planning Board - Legislator Keenan

Staff Reports

County Attorney - James Coffey, Esq.

Mr. Coffey requested an Executive Session at the end of the meeting to discuss potential litigation with Volo Aviation.

County Administrator - Michael Zurlo

Mr. Zurlo reported the Organizational meeting of the Clinton County Legislature will be held Thursday, January 3, 2019 at 5:15 p.m.

Mr. Zurlo thanked James Coffey for his service as County Attorney noting that they have worked together extremely well. Mr. Coffey is very thorough and always responded back to Mr. Zurlo very expeditiously.

Mr. Coffey stated he has thoroughly enjoyed working with everyone and was looking forward to traveling with his wife.

Legislator Dame also thanked Mr. Coffey for his service and noted his advice is always level-headed. He appreciated his demeanor and noted he has been an important asset to Clinton County.

Legislator Hall reported Mr. Coffey has done a fantastic job, and he will be missed by everyone.

Chairperson McManus stated he appreciates Mr. Coffey's responsiveness. He and the Legislature have been through potentially contentious issues—notably the Project Labor Agreement at Plattsburgh International Airport. Mr. Coffey presented both points of view for each side on the issue to the Legislature, and he very much appreciates his service to Clinton County.

There being no further business, Chairperson McManus moved on to resolutions. The following resolutions were approved unless otherwise noted.

Resolutions #1055 titled, "Appointing Acting Highway Superintendent" was approved.

Discussion: Mr. Zurlo noted this is a ministerial act so that someone can sign potential funding documents until a final appointment to the position has been made.

Chairperson McManus stated he believes the Legislature should begin the process of formally filling the Highway Superintendent position. His intention would be to sit down with the Deputy Highway Superintendent, review his credentials and invite the entire Legislature to participate in this process. After that is completed, the Legislature could decide how to proceed. Carried (9-0-1).

Resolutions #1056 through #1089 were approved. Carried (9-0-1).

Legislator Beach motioned to Waive Rule 13.2, seconded by Legislator Timmons. Carried (9-0-1).

Resolution #1090 was approved. Carried (9-0-1).

Legislator Henry motioned to enter into Executive Session at 7:29 p.m. to discuss potential litigation with Volo Aviation, seconded by Legislator Hall. Carried (9-0-1).

Legislator Hall motioned to exit Executive Session at 7:45 p.m., seconded by Legislator Henry. Carried (9-0-1).

There being no further business to come before the Legislature, Legislator Hall motioned to adjourn the meeting at 7:46 p.m., seconded by Legislator Conroy. Carried (9-0-1).
