may exceed the CPI rate, and may exceed 2 percent.

No Security Deposit required.

New Business Incentive - If AvFlight Corporation provides a lead on a prospective tenant for County-owned facility located on the Airport that results in a lease agreement with the prospect, AvFlight Corporation shall receive a new business incentive in the amount of 5 percent of rent per year

for the first three (3) years of initial term.
