Rodney Brown, Deputy County Administrator Jacqueline Kelleher, Esq., County Attorney Melody Lemieux, Principal Stenographer Chairperson McManus called the meeting to order at 7:01 p.m.

Following the pledge of allegiance to the flag, County Administrator Michael Zurlo conducted roll call. All Legislators were present.

Legislator Hall motioned to accept the minutes of the May 22, 2019 Regular Session, seconded by Legislator Keenan. Carried (10-0-0).

Chairperson McManus stated that there was a public hearing regarding proposed Local Law #1 of 2019 titled, "A Local Law to Establish a Sustainable Energy Loan Program (Open C-Pace) in the County of Clinton." He asked the Clerk of the Board to read the notice of public hearing.

Legislator Rosenquest motioned to open the public hearing at 7:03 p.m., seconded by Legislator Henry. Carried (10-0-0).

Chairperson McManus asked if anyone present wished to address the board regarding this matter. He stated if so, please state your name and address for the record. In accordance with the Rules of Order, speakers will be limited to five minutes.

There being no one who wished to speak, Chairperson McManus entertained a motion to close the public hearing.

Legislator Rosenquest motioned to close the public hearing at 7:04 p.m., seconded by Legislator Keenan. Carried (10-0-0).

Chairperson McManus invited Legislator Dame and Wayne Ashline to the podium. Legislator Dame presented Mr. Ashline with a copy of Resolution #419 dated May 22, 2019 titled, "Commending Clinton County Public Transit Bus Driver Wayne Ashline for His Lifesaving Efforts."

Chairperson McManus invited Legislators Henry and Timmons to the podium to read a Proclamation proclaiming June Dairy Month in Clinton County.

Chairperson McManus asked if anyone wished to address the Legislature.

There being no one who wished to address the Legislature, Chairperson McManus moved on to Committee reports.

Buildings and Grounds Committee - Legislator Peryea

Legislator Peryea reported the Buildings and Grounds Committee met Monday, June 10th.

The Committee learned that the Purchasing Agent is soliciting bids for the repaving/restriping of the Oak Street Parking Lot. Bids are due in the Legislative Office by Wednesday, June 19th. The Committee also discussed the proposed upgrades to the Government Center Parking Lot, the progress on both the Tool Room Project at the Highway Department and the Dannemora Properties Demolition Project.

Resolution #485 for change in funding of a permanent, full-time Medical Clerk/Typist-Health Department was also withdrawn.
