Mr. Dyer stated when he resigned his position as Area 3 Legislator in January, 2018 to become Town Supervisor, he was under the impression that the Legislature would be making an appointment (and a Special Election would not be held). Mr. Dyer asked the Legislature to consider utilizing unspent funding for his salary (for January, February and March, 2018) to help fund the Special Election which was held earlier this week. Mr. Zurlo stated this will be discussed at the April 10<sup>th</sup> Finance Committee meeting.

## Community Services Board – Legislator Conroy

Legislator Conroy reported the Community Services Board met Tuesday, March 27<sup>th</sup>. The Community Services Board discussed that the work that Substance Abuse Prevention and Recovery of Clinton County (SPARCC) is doing to reduce stigma for people with substance abuse issues and mental health issues to try and have more employers open to hiring these individuals.
