Chairperson McManus called the meeting to order at 7:01 p.m.

Following the pledge of allegiance to the flag, County Administrator Michael Zurlo conducted roll call. Legislator Waldron was excused.

Legislator Henry motioned to accept the minutes of the October 10, 2018 Regular Session, seconded by Legislator Hall. Carried (9-0-1).

Chairperson McManus stated there is a public hearing regarding the proposed Local Law #3 of 2018 titled, "A Local Law to Establish an Office of Public Defender". Mr. Zurlo, the Clerk of the Board, read the notice of public hearing.

Legislator Conroy motioned to open the public hearing at 7:03 p.m., seconded by Legislator Keenan. Carried (9-0-1).

Chairperson McManus asked if anyone present wished to address the Board regarding this Local Law.

Buildings and Grounds - Legislator Timmons

Clinton Community College - Legislators Dame and Rosenquest

Community Services Board - Legislator Conroy

Legislator Conroy stated the Community Services Board met on Wednesday, October 17th and discussed the Mobile Crisis Team, whose main goal is to reduce unnecessary emergency room visits by getting resources to individuals before situations escalate.

Cooperative Extension - Legislator Timmons

Legislator Timmons stated Cooperative Extension met last night, and after 31 years, Amy Ivy is retiring. Mr. Timmons was excited to report Ms. Ivy's replacement will be beginning in January 2019, as well as two new Board Members.

Resolutions #831 through #848 were approved.

Legislator Keenan motioned to Waive Rule 13.2, seconded by Legislator Rosenquest. Carried (9-0-1).

Resolutions #849 and #850 were approved.

Chairperson McManus extended an invitation to the Legislators to attend a press event tomorrow, Thursday, October 25th at 2 p.m. to announce the partnership between the County, the Town of Plattsburgh and The Development Corporation (TDC) for the redevelopment of the former Clinton County Airport property and the fact that the three entities are applying for an Economic Development Agency Grant.

Mr. McManus stated the press conference will be at a site immediately adjacent to where the former County Airport Terminal Building was located.

Legislator Hall motioned to enter into Executive Session at 7:38 p.m., seconded by Legislator Rosenquest. Carried (9-0-1).

Legislator Rosenquest motioned to exit Executive Session at 8:18 p.m., seconded by Legislator Keenan. Carried (9-0-1).

There being no further business, Legislator Rosenquest motioned to adjourn the meeting at 8:18 p.m., seconded by Legislator Hall. Carried (9-0-1).

Re: September OTB Board Meeting and Facility Update

Summary Points and Administrative Actions:

(Capital District OTB includes 17 Counties – Albany, Clinton, Columbia, Cortland, Essex, Franklin, Fulton, Greene, Herkimer, Madison, Montgomery, Oneida, Rensselaer, City of Schenectady, St. Lawrence, Warren, and Washington)

- 1. Clinton County/Plattsburgh Branch Facility is up, after the first 7 months ending July 31, 2018 (compared to 2017's first 7 months), \$53,776.00!!
- 2. Clinton County's Internet waging from August 31, 2017 to August 31, 2018 is down \$3770.
- 3. Saratoga Thoroughbred Racing Season
 - A. Capital District OTB Handle was up \$644,747 over last year (2.22%)
 - B. Capital Internet Handle was up \$1.9 million over last year

- 4. Capital District OTB Handle for the first 7 months of 2018 (ending July 31, 2018) was \$84,025,432, NOT including the Saratoga Meet.
- 5. Capital OTB's Operating Expenses were down more than \$1million over 2017 because of branch closures, new leases/lease renewals, retirements, and re-structuring of the Administrative staff.
- 6. Plattsburgh Branch, under the leadership of Lisa Letourneau, has received multiple Outstanding ratings this year and as of 9/24/18, has paid total cash disbursements to Clinton County of \$23,994.
