Section 1. Purpose.

The Civil Service Law which currently is administered in the County of Clinton by a municipal civil service commission as described by Section 15-1(a). The Clinton County Legislature is authorized by Section 16 of the Civil Service Law to elect optional forms of administration of the Civil Service Law.

Section 2. The Clinton County Legislature hereby elects to administer the Civil Service Law for the County of Clinton by a Personnel Officer to be appointed by the Board of Legislators, as described in Section 15-1(b), who shall have among other duties, the same powers and duties of the former municipal civil service commission.

Section 3. Effective date of the form of administration to a Personnel Officer shall take place one (1) year from the date of passage of this Local Law.
