A local law Electing an Open Retirement Incentive Program as Authorized

By Chapter 643 of the Laws of 1992 for the Eligible Employees
of Clinton County

of Clinton as follows:

- Clinton County hereby elects to provide all its eligible employees with a retirement incentive program authorized by Chapter 643, Laws of 1992. This is an untargeted program.
- The commencement date of the retirement incentive program shall be September 16, 1992, and it shall terminate on October 30, 1992 at 5:00 p.m., and applications for retirement hereunder must be filed with the New York State Retirement System, with notification to the Clinton County Department of Personnel on or before October 10, 1992, effective not later than October 30, 1992 at 5:00 p.m.
- The open period during which eligible employees may retire and receive the additional retirement benefit shall be forty-five (45) days in length.
- The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be funded over a five year period. The amount of the annual payment in each of the five years shall be determined by the Actuary of the New York State and Local Employees' Retirement System, and it shall be paid by Clinton County for each employee who receives the retirement benefits payable under this local law.
- Termination benefit payment of accumulated unused sick leave shall be paid at the salary rate payable on the final day of employment. This payment shall be made in three equal installments as follows:

1st Installment	January 15, 1993
2nd Installment	July 16, 1993
3rd Installment	January 28, 1994
- This act shall take effect upon filing with the Secretary of State.
