WHEREAS, Resolution #689 dated August 28, 2019 authorized the Purchasing Agent to solicit bids for three Clinton County bridge projects as follows: Replacement of the Tappin Road Bridge over Great Chazy River, BIN 3336260, Town of Mooers; Replacement of the Harney Bridge Road Bridge over Saranac River, BIN 3335770, Towns of Plattsburgh and Schuyler Falls; and Removal of the Kent Falls Road Bridge over Saranac River, BIN 3335790, Towns of Plattsburgh and Schuyler Falls; and

WHEREAS, bids were opened by the Purchasing Agent on October 8, 2019; and
