WHEREAS, due to the parking lot expansion (as part of the Terminal Building Expansion Project at the Plattsburgh International Airport) the additional area requiring snow removal exceeds the equipment and services the Clinton County Highway Department is able to provide; and

WHEREAS, Resolution #375 dated June 8, 2016 authorized the Purchasing Agent to solicit bids for the snow plowing, snow removal, salting and sanding of the Plattsburgh International Airport Passenger Parking Lot; and

WHEREAS, the Purchasing Agent opened bids on Thursday, September 1, 2016; and


